### **Senior Citizen Property Tax Deferral**

The following categories of sales or types of transactions are generally exempted from the sales/use tax: Food & clothing. Sales of food for human consumption (other than meals sold by a restaurant) and clothing costing \$175 or less. For items that cost more than \$175, sales tax is only due on the amount over \$175 per item.
